# PLEASE OBSERVE THE FOLLOWING SKATEPARK RULES

### FOR YOUR SAFETY

- Park is for skateboarding and other nonmotorized wheeled recreational devices only, as defined in Health and Safety Code section 11580(d). All other uses are prohibited.
- All users must wear commercially manufactured safety gear, helmet, elbow pads, and kneepads.
- Failure to wear safety equipment will result in loss of park privilege and is subject to citation. (CMC Sec. 56.28.045)
- Be aware that using the park is inherently dangerous and hazardous recreational activity and could result in serious bodily injury or death. By using the park, users assume all risks and understand that the City is not liable for any injuries incurred in the park. All users must have a liability waiver on file. For users under 18 years of age, parent/guardian must sign release forms in person or online.
- Minimum age is 6 years old; proof of age is required.

- All users must ride safely at all times and avoid collisions with others.
- Fighting or other disruptive behavior will result in loss of use privileges.
- Users must abide by staff instructions at all times.
- All equipment used must be in good condition.
- Shirts must be worn at all times.
- Spectators are not permitted inside the park.
- Notify staff immediately of any unsafe conditions found inside or outside the park.
- The City reserves the right to change park hours or close the park. Park will not be open during inclement weather.
- City is not responsible for personal property.
- Comply with CMC 56.28.045 and all City ordinances.
- Follow all posted signs.
- Hours of operation vary by season.

## FOR THE ENJOYMENT OF ALL PARTICIPANTS, THE FOLLOWING IS PROHIBITED:

- Smoking, alcohol, drugs and chewing gum/tobacco, spitting.
- Littering, glass bottles, containers or fires.
- Aggressive or threatening conduct.
- Trespassing.
- Skating in parking lot, on sidewalks, curbs, or entrance areas near the Skatepark.
- Contests of any sort are not allowed in the park unless organized by recreation staff.
- Graffiti, tagging, or other means of defacing City property.
- No food or drinks on skating surfaces.

## BICYCLE EQUIPMENT REQUIREMENTS:

- Bicycles used in the Skatepark must meet the following criteria:
  - BMX bicycles intended for jumping, riding on dirt, streets or in skateparks.
  - Wheel size of 26" or less.
  - Hard tail (no rear suspension) or front suspension (dirt jumpers) of 100 millimeters of travel or less
  - Single Speed.
  - All other types of bicycles are disallowed including but not limited to: bicycles intended for downhill, cross country, mountain, trail, rear suspension, tandem, 10 speeds, 29ers, track, fixed gear, road, beach cruisers, folding, motorized bicycles, electric, tricycles, unicycles, big wheels, stair cycles, free riding, muddy tires, faulty, damaged, broken or unsafe.
- Bicycle accessories:
  - Pedals must be aluminum or plastic.
  - Handlebars must have end caps covering the end of the bars.
  - Skatepark staff in their sole discretion may determine if a bicycle complies with regulations and can be riden in Skatepark.
  - Prohibited Accessories include: kick stands, training wheels, trailers, side cars, foot pegs and baskets.
